Any mutually agreed additional services such as travel expense the wedding planner may incur will be paid by the bridal couple. A non refundable deposit of \u00a3500 is to be sent with this signed contract to secure a booking. 75% of the balance is due 6 weeks before the wedding day and the final balance on the day itself.
