- Automatic Perfection - Some security interests are automatically perfected, either permanently or temporarily, upon attachment of the security interest to the collateral. ? Example: A Purchase Money Security Interest (PMSI) is a transaction in which a lender provides funds or financing to purchase the collateral securing the loan. If the collateral is a consumer good, the lender is automatically perfected.

Security Interests in Personal Property

The PPSA defines a security interest in Section 12 (1). Here, a security interest is: A transaction that provides an interest in personal property and, in substance, secures payment or a performance of an obligation regardless of the form of the transaction. Personal property is any property other than real estate.
